PHYSICIAN ASSISTANT LICENSURE INFORMATION PACKET

This packet contains all of the documents you will need to apply for a license in Arkansas. This packet and each of its components are available on our web site, www.armedicalboard.org. If you received this packet from a source other than directly from the Arkansas State Medical Board or its official website, the application may be outdated or not an official version. Please be advised that outdated or unofficial versions of the application will not be accepted.

*** IMPORTANT INFORMATION - PLEASE READ CAREFULLY ***

ABANDONED APPLICATIONS. Applications which are not complete after twelve (12) months will be classified as Abandoned and will be removed from our system. Further, pending applications will be listed as abandoned if the applicant does not communicate with the Board office for six (6) months. Abandoned files will be maintained for 30 days and then destroyed. No refunds will be given on abandoned/inactive applications.

APPLICATION FEES. The fee for full licensure is \$5 (five) (\$4 (four) application fee plus \$1 (one) for temporary license), and must be included with your application at the time of submission. Payment may be made by check or money order payable to ASMB - Arkansas State Medical Board. **Do not send cash.**

APPLICATION REVIEW. The application review process is defined by the requirements set forth in state law. The Board and its staff must comply with those laws in processing applications. Applications are processed in the order in which they are received in our office and in the order verifications are obtained. **THE BOARD DOES NOT ACCELERATE ONE APPLICANT OVER ANOTHER.**

ARKANSAS MEDICAL PRACTICES ACT AND RULES. The Arkansas Medical Practices Act and Rules must be read in their entirety prior to submitting an application for a Physician Assistant license to the Arkansas State Medical Board. You **MUST** complete the Medical Practices Act and Rules Affidavit located in this packet. Applications received without this form will be returned. The Medical Practices Act can be viewed and downloaded from our web site, www.armedicalboard.org.

CHANGE OF ADDRESS. Rule 33 requires you to notify the Arkansas State Medical Board of any changes to your address within 30 days of such change. This includes your relocation to Arkansas, if applicable. A Change of Address form is available for download at our website, www.armedicalboard.org. **THIS ADDRESS CHANGE MUST BE IN WRITING.** The form must be fully completed, signed and dated. Once you are licensed you may change your address online.

CHECKING THE STATUS OF YOUR APPLICATION. The Arkansas State Medical Board's required form of communication is an interactive Applicant Portal system which allows communication between the Board and the applicant via the web. We have found that this system is a very effective communication tool and significantly reduces the time to licensure once your access identification has been assigned. Once your access identification has been assigned, you may access the Applicant Portal system from any computer at any time by visiting the Medical Board's web site at: <http://www.armedicalboard.org>.

When using the system, you will see a status bar which will show the percentage completed of your application process. Additional information regarding items that need your attention will be provided to you via a "Click

here to respond” link on the “Applicant Portal Home” page. You will need to access your open items by choosing this link and providing a response to the items for which a response is requested.

This interactive system allows the Licensing Coordinator the time necessary to work your file as opposed to responding to numerous phone calls or e-mails from various interested parties checking on the status of your application. It also allows you to review the progress of your application at any time. You may choose to provide access to your Applicant Portal to others; however, once you allow this access, all communication in the system will be viewable. This means that all questions including health or disciplinary issues occurring in other states or institutions will also be viewable.

After all verifications have arrived, your file will be checked to ensure all time gaps have been accounted for in your time line. If they are not, you will be asked to document your activity during those specific times. Although this seems insignificant, it is very important to the Board. This step cannot be skipped. Once all verifications have arrived and all time gaps filled, your application file will be presented for licensure consideration.

COMMITTEE APPEARANCE. Applicants and supervising physicians may be required to appear together before the Physician Assistant Advisory Committee prior to licensure, and may also have to appear when there is a change of supervising physicians. Meeting dates may change at the discretion of the Committee or the Arkansas State Medical Board. Meeting dates are available on our website, www.armedicalboard.org. If you must appear for licensure, appearance dates will be provided to you by your Licensing Coordinator.

COMPLETING THE APPLICATION. READ THE INSTRUCTIONS FOR EACH QUESTION BEFORE ANSWERING. The application may NOT be submitted electronically or by fax, as we do require your original signature on the hard copy. Please type or print legibly in dark blue or black ink. Provide exact dates (mm/dd/yyyy) whenever possible. ANSWER ALL QUESTIONS/ SECTIONS, even if your answer is “n/a,” “Not Applicable,” “None” or “Pending”. All signatures must be the applicant’s; stamped signatures, signatures by proxy, and signatures by power of attorney are NOT accepted for documentation or verification purposes. Make sure all required seals are affixed on the application, all questions have a response, and all documentation has been certified. Your application and verifications will be returned to you if they are incomplete or if photos are not attached where required. Pages must be printed on one side only. Two sided (front and back) applications will cause delays due to pages needing to be resubmitted.

CRIMINAL BACKGROUND CHECK. Act 1249 of 2005 authorizes the Arkansas State Medical Board to conduct criminal background checks (both state and federal) on ALL applicants for licensure.

Arkansas Code 17-95-306 states:

(a) (1) Beginning July 1, 2005, every person applying for a license or renewal of a license issued by the Arkansas State Medical Board shall provide written authorization to the board to allow the Arkansas State Police to release the results of a state and federal criminal history background check report to the Board.

(2) The applicant shall be responsible for payment of the fees associated with the background checks.

Upon receipt in this office of your completed application and fee, a CBC packet, including forms and instructions, will be sent to you for completion. You need to complete and return these forms at your earliest convenience. The Federal portion of this background check can take two weeks or more to process. ASMB will NOT accept a previously obtained criminal background check, regardless of how recently it was performed or what organization provides it. Payment for the CBC must be made by money order. Complete instructions will be provided in the CBC packet. It is imperative that the completed CBC packet be returned to the Board in a timely manner as failure to do so will delay licensure.

FCVS. The Federation Credentials Verification Service (FCVS) is a service provided by the Federation of State Medical Boards (FSMB). It is NCQA-certified for credentials verification and meets The Joint Commission’s ten principles for a primary source verified credentials verification organization. FCVS staff uses primary sources to verify a practitioner’s identity; education and more; and creates a permanent profile of the verified credentials. The profile can be updated as needed throughout a practitioner’s career and sent to boards and other entities without the need to verify each item again.

If you are using FCVS for credentials verification, do not provide a copy of your driver’s license or passport, or a copy of any name change documents to the Board. Also, do not request examination scores/transcripts,

verification of PA program and official transcript to the Board. FCVS will provide these verified credentials to the Board on your behalf.

To use FCVS, visit <http://www.fsmb.org> and select "FCVS" from the Sign In menu in the upper right corner. Sign in and continue as directed. Complete an Initial Application if you are using FCVS for the first time. Complete a Subsequent Application if you need to update your existing FCVS profile. During the application process, you will need to designate your profile to be received by the Arkansas State Medical Board. The Board will not accept any FCVS profile with a Self-designation. For assistance, contact FCVS through the messaging tool within FCVS, or call 888-275-3287 with your FCVS ID number.

FOREIGN LANGUAGE DOCUMENTS. All foreign language documents submitted by applicants and verification sources must be accompanied by a translation into English by an official translator. Documents received without an official translation will be returned to the applicant for forwarding to an official translator. The translated document must then be returned to the Board directly from the translator.

LICENSE RENEWAL. Your Physician Assistant license, if granted, must be renewed annually on or before the last day of your birth month. There is no grace period. Your first renewal notification will be sent to you via e-mail 60 days prior to the end of your birth month. A follow-up email will be sent at approximately 45 days and a final email notification will be sent 30 days from the last day of your birth month. Failure to receive notice is NOT considered an excuse for nonrenewal. Failure to renew before midnight on the last day of your birth month will cause your license to automatically expire. If your license expires, you will be assessed a \$25.00 late fee to reinstate your license. *****REMINDER***** **It is illegal to practice as a Physician's Assistant in this State with an inactive or lapsed license or permit.**

PROCESSING TIME. Processing delays are almost always attributable to lengthy work histories and delays in receiving the verification documents you request. If you have a history of malpractice, disciplinary action, impairment history, etc., additional time will be required for our investigation. Processing a permanent license application will take several weeks to complete. Please plan for this. Do not make commitments, purchase a home, or relocate your family before your Arkansas Physician Assistant license has been granted. Applications are processed in the order in which they are received in our office and in the order verifications are obtained. The Board does NOT accelerate one applicant over another.

DELEGATION AGREEMENT REQUIREMENT. The Delegation Agreement is a physician drafted document which describes how you and the physician will work together with practice guidelines required by the supervising physician. It must delineate the scope of practice that you will engage in and how you will be evaluated and supervised. You are strongly encouraged to use the "Delegation Agreement" found on the ASMB website as a template, as the document contains parameters required by the PA Advisory Committee and the foundation for basic patient treatment by a PA. You may add or delete services and/or procedures as it applies to your working relationship. Each area listed on the "Delegation Agreement" must be included in your submitted document or it will be returned for completion.

SUBMITTING THE APPLICATION. The application may NOT be submitted electronically, as we do require your original signature on the hard copy and all fees to be paid at submission.

SUPERVISING PHYSICIAN. By law, Physician Assistants are allowed to practice only under the supervision of a licensed physician. It is the responsibility of the PA to keep this office informed of your current Supervising Physician in Arkansas. Additionally, it is the policy of the Board that a Supervising Physician may have authority over multiple Physician Assistants; however they may only provide direct supervision for up to three (3) Physician Assistants at one time.

BIOLOGIC PRESCRIPTIVE AUTHORITY: If you will be prescribing biologic medication, the Request for Biologic Prescriptive Authority form must be completed. The submitted form should be reviewed and approved by the Board prior to prescribing these types of medication.

TEMPORARY PERMITS. A temporary permit may be granted to an applicant who meets all the qualifications for licensure but is awaiting a licensing determination or the next scheduled meeting of the Physician Assistant Advisory Committee. Consideration of a temporary permit can be made only when the application process is completed in its entirety. The temporary permit will expire at the next scheduled meeting unless extended, and can be extended only once. If granted a temporary permit and the applicant is required to appear before the committee for licensure, the applicant must appear with his or her Supervising Physician for approval of the Delegation Agreement within four (4) months of when the first temporary permit was granted.

TIME GAPS. Any time gaps of 30 days or more must be explained in writing. You will be notified of any unexplained time gaps and asked to provide an explanation. To avoid processing delays, please include a separate, signed explanation of any time gaps of 30 days or more with your original application. Failure to address time gaps will result in delay of licensure.

U.S. POSTAL SERVICE. If you choose to utilize the U.S. Postal Service, please be advised that they do NOT guarantee delivery of first class mail, and they do NOT guarantee delivery of Certified mail. Based on the lengthy delays we have experienced in receiving mail which has been sent to us, we strongly recommend you utilize FedEx, UPS, or other *guaranteed* delivery service when sending your application or other documents to us. We further recommend that when sending verification requests to primary sources, you provide them with a prepaid FedEx, UPS or other delivery service envelope to ensure that their correspondence reaches us in a timely manner.

VERIFICATIONS. It is the policy of this board that ALL education, training, and professional affiliations and other activities since graduation from Physician Assistant school (or within the past 5 years whichever is less) be verified by the primary source prior to issuance of a permanent license. It is the applicant's responsibility to request verifications and to follow up with organizations to ensure verifications are returned. Applicants are required to sign verification documents where indicated in Part II prior to sending to verification source. The verifier's signature can be original, stamped or computer-generated. All verifications can be faxed or e-mailed unless specifically requested to be mailed. To fax, send to (501) 296-1972. To e-mail, the document must be sent as an Adobe .pdf attachment to support@armedicalboard.org with "Attn: Licensing" in the Subject line. Note that if the attachments are not sent in this format and to this address, they will be stripped by the firewall and will not be received by the intended recipient.

WITHDRAWN APPLICATIONS. Applications which are withdrawn by the applicant will be maintained for 30 days and then destroyed. No refunds are given on applications that are withdrawn.

"YES" RESPONSES. A "Yes" response in the attestation portion of the application does not mean your application will be denied. If you have responded "Yes" to any of these questions, additional time will be required for the gathering and assessment of pertinent information. You will be required to provide a separate, signed and complete explanation for each "Yes" response; you can expedite this process by including these with your original application. Failure to appropriately answer questions may result in an appearance before the Board for full licensure; disciplinary action; and/or denial of a license.

PHYSICIAN ASSISTANT REQUIREMENTS FOR LICENSURE IN ARKANSAS

ARKANSAS MEDICAL PRACTICES ACT, 17-105-102 (b) AND RULE 24: THE BOARD MAY GRANT A LICENSE AS A PHYSICIAN ASSISTANT TO AN APPLICANT WHO:

- (1) Submits an application on forms approved by the board;
- (2) Pays the appropriate fees as determined by the board;
- (3) Has successfully completed an educational program for physician assistants or surgeon assistants accredited by the Committee on Allied Health Education and Accreditation or by its successor agency and has passed the Physician Assistant National Certifying Examination (PANCE) administered by the National Commission on Certification of Physician Assistants (NCCPA).
- (4) Certifies that he or she is mentally and physically able to engage safely in practice as a Physician Assistant;
- (5) Has no licensure, certification, or registration as a Physician Assistant under current discipline, revocation, suspension, or probation for cause resulting from the applicant's practice as a Physician Assistant, unless the board considers such condition and agrees to licensure;
- (6) Submits to the board any other information the board deems necessary to evaluate the applicant's qualifications;
- (7) Has been approved by the board;
- (8) Is at least twenty-one (21) years of age; and
- (9) After July 1, 1999, has at least a bachelor's degree in some field of study from a regionally accredited college or university, unless the applicant has:
 - (A) Prior service as a military corpsman and is a graduate of a Physician Assistant education program recognized by the Committee on Allied Health Education and Accreditation or the Commission on Accreditation of Allied Health Education Programs or the applicant is currently certified by the National Commission on Certification of Physician Assistants.
 - (B) Was serving as a Physician Assistant in a federal facility located in the State of Arkansas on or after July 1, 1999, and who is a graduate of a Physician Assistant education program recognized by the Committee on Allied Health Education Programs;
 - (C) Was licensed in good standing on July 30, 1999, by the Arkansas State Medical Board; or
 - (D) Was enrolled on or before July 1, 1999 in a Physician Assistant program recognized by the Commission on Accreditation of Allied Health Education Programs.

LICENSURE IS BY CREDENTIALS:

- Credentials must be verified from the originating source; verifications received from applicants will be returned

LICENSING EXAMINATIONS MEETING THE BOARD REQUIREMENTS ARE AS FOLLOWS:

- Physician Assistant National Certifying Examination (PANCE)

You are required to provide the following documents to the Arkansas State Medical Board (documents marked with an asterisk (*) are not required if you are utilizing the FCVS):

- Check or money order, made payable to ASMB, in the amount of \$5 (five), for temporary and full licensure.
- Application, signed, with photo attached and certification by Notary Public. Signature must be original and must be made in black or dark blue ink. Stamped signatures, signatures by proxy and signatures by Power of Attorney are NOT accepted. Do not complete the application on front and back pages. Use one sided pages only.
- Signed and dated explanations for any "Yes" answers in Part IV of the Application. Attach all pertinent documentation.
- Signed and dated explanations/descriptions of all malpractice claims made against you
- Signed and dated explanations for any time gaps of 30 days or more since the end of education
- Completed Physician Assistant Authorization and Release (form in packet)
- Completed Arkansas Medical Practices Acts and Rules and Regulations Affidavit (form in packet)
- Completed Secondary Contact Designation if desired (form in packet)
- CBC Privacy Right Statement
- Current Curriculum Vitae (CV) (Sign and date)
- Copy of Driver's License or Passport *
- Copies of all previous and current Federal DEA registration certificates and state-issued controlled substance registration certificates
- Copy of name change documents, if applicable *
- Copy of proof of citizenship, naturalization, visa, or work permit, if applicable (*if not born in the U.S.*) *
- Copy of DD Form 214 (Certificate of Release or Discharge from Active Duty), if you have been released or discharged from any branch of the U.S. Armed Forces at any time during or since Physician Assistant School

YOU are required to request the following documents from their primary sources, and these documents must be sent from the primary source directly to the Arkansas State Medical Board (forms marked with an asterisk (*) are not required if you are utilizing the FCVS):

- Verification of Undergraduate Education and Official Transcript** (form in packet)
Complete Parts I and II, sign and then send a copy to the Dean or Registrar of each college, university, or technical school you attended.
- Verification of Physician Assistant Education and Official Transcript** (form in packet) *
Complete Parts I and II, sign and then send a copy to the Dean or Registrar of each Physician Assistant school you attended.
- NCCPA PANCE Results/Eligibility** *
Go to <http://www.nccpa.net>. If you have taken and passed the exam, request the Exam Results be sent. If you have not taken the exam, request the Eligibility Letter be sent.

Verification of Licensure (form in packet)

The applicant is no longer required to request verification of their out-of-state Physician Assistant licenses, except for those states that do not provide free, online verification through their website (MS and SD, for example). In these states, the applicant will be required to request verification and pay any required fees. If any verifying source charges a fee for verification, does not offer online verification, or if their website has not been updated, the applicant is responsible for requesting verification and paying any fees. Complete Parts I and II of the form, sign and then send a copy to the licensing board.

Verification of Hospital/Clinic Physician Assistant Affiliation (form in packet)

Complete Parts I and II, sign and then send to the Medical Staff Office or Administration Office of every hospital and every clinic that granted you Physician Assistant privileges or employed you as a Physician Assistant in the last five (5) years or since graduation from Physician Assistant school, whichever is shorter.

Locum Tenens: Verification from each assignment facility is no longer required, as long as the locum tenens contract firm can provide a list of all of the applicant's assignments with exact dates.

Professional Liability Verification (form in packet)

The ASMB does NOT require applicants to have malpractice insurance prior to licensure. However, if you do carry malpractice insurance, send this form to every insurance company that currently insures you against malpractice claims. The completed form may be returned to ASMB by fax.

Malpractice Claims Documents

If, in the ten (10) years prior to the signature date of your application, you had a malpractice lawsuit filed against you OR if a malpractice settlement or judgment of \$500,000 or more has **ever** been issued against you, you must submit a separate, signed and dated explanation of the circumstances for each lawsuit. Court documents are not required to be submitted for malpractice cases. If the case is settled, the NPDB report will suffice. If the claim is dismissed with no settlement, the applicant must have the insurance company provide a claims history report. For pending cases, the attorney must provide a narrative of the case. However, the applicant is still required to submit a signed and dated narrative for each case which meets the criteria set forth above.

Verification of Military Service (form in packet)

If you are active duty or in the Reserves, complete the top portion of the form and then send with a copy of the Physician Assistant Authorization & Release form (also in this packet) to your current duty station or you can have your Commanding Officer send a letter to the Board. If you are inactive military, you only need to provide a copy of your DD Form 214. If you do not have a copy of your DD214, go to <http://www.archives.gov/veterans/military-service-records/> to request online.

Delegation Agreement (example in packet)

Complete the Delegation Agreement. Signatures of the Physician Assistant, Supervising Physician and Back-up Supervising Physician(s) are required. (The applicant can provide this document to the Board.)

Request or Biologic Prescriptive Authority (form in packet)

Complete the document in accordance to which authority you are requesting (check boxes indicate your specific request). Signatures of the Physician Assistant, Supervising Physician, license numbers and dates are required.

Physician/Professional Reference/Recommendation Letter

Only one (1) signed and dated letter of recommendation is required. It cannot be from a physician who will be your supervising physician in Arkansas. To assure timely processing of your application, please communicate the following guidelines for submitting recommendation letters to the Board:

- Letter must be written or typed on standard size paper or letterhead and must include the date, address, and phone number of the sender. The name of the sender must be legible.
- Letter can be e-mailed to the Board from the reference's personal e-mail address.
- Letter must include your full, legal name. If an alternate name, nickname or the English translation is used, your full, legal name must still be referenced somewhere in the letter.
- Letter must indicate whether or not they have worked with the applicant and state the work experience with the applicant regarding his or her knowledge base.
- Letter must indicate their observation of the applicant's integrity or character.

INSTRUCTIONS FOR COMPLETING LICENSURE APPLICATION

READ CAREFULLY!

Indicate if you will be utilizing the Federation of State Medical Board's FCVS for your Arkansas license.

Indicate if you are a current or former member of the United States military or are the spouse of a current or former member of the United States military.

Question 1: Your name

- Enter your legal name as listed on your driver's license. If your name has changed due to marriage, divorce, adoption or naturalization, submit a notarized copy of pertinent document.
- Enter any other names used during your education or career, such as maiden name, nicknames, etc.

Question 2: Your identification

- Enter your social security number.
- Enter your driver's license number and state of issuance. *Send a copy of your driver's license with your license application.*
- Check male or female.
- Enter your date of birth (mm/dd/yyyy).

Question 3: Birthplace/Citizenship

- Enter the city and state (or city and country) where you were born.
- Enter the name of the country of which you are a citizen. *If you are a U.S. citizen but you were born in a foreign country, send a copy of your proof of citizenship.*
- If you are not a U.S. citizen, enter your immigration status. *Send a copy of your current Visa or Work Permit.* If you are a U.S. citizen, enter "n/a".
- If you are not a U.S. citizen, enter the number of years and/or months that you have lived in the U.S. If you are a U.S. citizen, enter "n/a".
- Indicate your ethnicity by checking the appropriate box.
- Indicate your race by checking the appropriate box.

Question 4: Your contact information (Both address sections must be completed, even if they are the same.)

- Enter your Public mailing address. **This field is required.** This address appears on all printed reports, bulk data listings, the Online Directory and the free, online license verification system. It is also available to the general public under FOI and all other reports available to the credentialing organizations utilizing the ASMB website for license and/or credentials verification.
- Enter your Private mailing address. **This field is required.** The Private address is used to send renewal reminders, direct and confidential communication from the Board and the Board's

quarterly Newsletter. It is NOT available to the public under FOI unless you also use this address as your public address.

- Enter your private, work, fax, and mobile phone numbers in the appropriate spaces.
- Enter your **personal** e-mail address. **Your personal e-mail address is required.** This is the e-mail address through which you will receive automated system messages as to the status of your application. You may also receive private and confidential e-mails for clarification purposes from the licensing staff. This is NOT your primary contact's e-mail address, as this e-mail address will carry over towards the required online renewal setup.

Question 5: Intended Practice Location

- Enter the name of the hospital, clinic, group or private practice where you will be practicing.
- Enter the mailing address of the hospital, clinic, group or private practice where you will be practicing.
- Enter the name of the physician that will be your Supervising Physician. If you have not found employment at the time of application, enter "pending."
- Enter your Supervising Physician's specialty. Please note that, per Rule 24(7)(D), *"The supervising physician and back-up supervising physician must be skilled and trained in a similar scope of practice as the tasks that have been assigned to and will be performed by the Physician Assistant that they supervise."*
- Enter the name of the physician that will be your Back-up Supervising Physician.
- Enter your Back-up Supervising Physician's specialty.

Question 6: Undergraduate Education

- Enter the full name of the college or university where you completed your undergraduate education. The application has space for two different schools in case you transferred. If you attended more than two schools, additional sheets may be attached.
- Enter the mailing address of the college or university.
- Enter the date you started attending the college or university.
- Enter the date you left the college or university (graduated or left before completion).
- Answer "Yes" if you graduated, "No" if you did not graduate.
- Enter the degree you were awarded, or list the reason why you did not graduate (transferred schools, extended leave of absence, etc.). *If you did not graduate, you must submit a separate, signed and dated explanation of the circumstances.*

Complete the top portion of the "Verification of Undergraduate Education" form contained in the application packet, and send one to each college or university you attended. Forms must be returned directly to this office from the institution.

Question 7: Physician Assistant Education

- a. Enter the full name of the college or university program where you completed your Physician Assistant education. The application has space for two different programs in case you transferred. If you attended more than two programs, additional sheets may be attached.
- b. Enter the mailing address of the program.
- c. Enter the date you started attending the program.

This agreement sets forth the terms of the Delegation Agreement between _____ (Physician Assistant)

This agreement shall take effect as of _____.

Introduction:

_____ (Physician Assistant) meets the qualifications and practice requirements as stated in the Arkansas State Medical Board licensure, holds an Arkansas state license and is currently registered as a Physician Assistant in good standing, holds a certificate as a certified Physician Assistant pursuant to the Arkansas State Medical Board licensure and herein meets the requirement of maintaining a delegative practice agreement with _____ (Physician), a duly licensed and currently registered physician in good standing under the laws of Arkansas State Medical Practices Act.

Scope of Practice:

The practice of a Physician Assistant may include the diagnosis of illness and physical conditions and the performance for therapeutic and corrective measures including prescribing medications for patients whose conditions fall within the authorized scope of the practice. This privilege includes the prescribing of all controlled substances under a DEA number for which Practitioner is duly licensed to prescribe. All patients who receive a Schedule II prescription will have their chart reviewed by the supervising and/or backup supervising physician. The Physician Assistant may also diagnose and treat human responses to actual or potential health problems through such services as case finding, health counseling, health teaching, and provision of care supportive to restorative of life and well-being. Also, Physician Assistant may perform simple procedures which are within the practitioner's scope of practice.

Practice Delegation Agreement:

The delegation agreement used in this practice will be located in the practice office for reference.

Physician Consultation:

The parties shall be available to each other for consultation either on site or by electronic access including but not limited to telephone, facsimile, and email. In the event that there is an unforeseen lack of coverage, patient will be referred to the appropriate emergency room.

Provision for Absence of Supervising Physician:

In the unexpected event that the supervising physician of record must be absent due to extended illness or leave of absence, the PA shall be notified and an interim acting backup supervising physician shall be determined. It will then be the responsibility of the PA to notify the Arkansas State Medical Board of the change in practice.

Record Review:

A representative sample of patient records, 10% of charts per month, shall be reviewed by the supervising physician every month to evaluate that _____ (Physician Assistant)'s practice is congruent with the above identified practice delegative agreement. Summarized results of this review will be signed by both parties and shall be maintained at the practice site.

Alteration of Agreement:

The delegative practice agreement shall be reviewed at least annually and may be amended in writing in a document signed by both parties and attached to the original delegative practice agreement.

Practice Agreement:

The clinical PA will work in agreement with the _____ (Physician) and the delegative agreement will be enforced through following the practice guidelines. It is the intent of this delegative agreement to ensure complete compliance with all Arkansas Medical Practices Act and Rules.

Basic Practice Standards:

Basic practice standards include assessment, examination, diagnoses, treatment, referral and consultation as appropriate within the PA's scope of practice.

Methods of Delegation:

The physician delegation with the PA will be attained through a variety of means:

- Regular communication in person, when possible, or via telephone if necessary.
- Monthly chart audits, to include a review of 10% of charts of a representative sample of the PA's patient population for the given month. In order to prevent the diversion of controlled substances, the PA will provide the physician with any Prescription Monitoring Program report on any patient the physician requests at time of audit.
- Quarterly meetings with the PA, including documentation of meeting and topics discussed. Delegation agreement will be updated once per year with any updates regarding current delegation agreement.

The supervising physician will be contacted as needed for all conditions which exceed the PA's scope of practice or exceeds the agreed limitations outlined in the delegative agreement.

To ensure the continuity of the delegative process, _____ (Physician) will serve as a backup supervising physician in the event the primary supervising physician is unavailable.

Liability Malpractice Coverage:

A supervising physician will notify the Arkansas State Medical Board within 10 days after notification of a claim or filing of a lawsuit for medical malpractice against a Physician Assistant, whom he supervises in accordance with Rule 24.

Ordering, Performing and Interpreting Laboratory Tests:

The PA will order and interpret any test(s) necessary to the medical evaluation of the patient. Examples of laboratory and diagnostic tests that the PA may order, perform or interpret include but are not limited to:

- Complete blood count
- Serum chemistry
- Thyroid function tests
- X-rays, EKG's (final interpretation by physician)
- Urine drug screening
- Other preventative/diagnostic tests

Prescribing:

The PA may order controlled substances covered by the PA's Controlled Substance Registration with the U.S. Drug Enforcement Agency (DEA). The supervising physician shall be identified on all prescriptions and orders of the patient in the patient chart if issued by the PA. The PA shall only prescribe in accordance with guidelines set forth in Rule 24.

The PA will prescribe medications as necessary and appropriate for the practice and in accordance with state and federal law.

The PA will not prescribe the following non-controlled medications:

- Chemotherapeutic agents
- Immunosuppressive agents (with the exception of steroids)
- Thrombolytic agents (Does not include anti-thrombolytic medication such as Heparin, Lovenox, Coumadin, etc.)

Telemedicine:

Any telehealth provided shall be conducted within the parameters of the Laws & Rules governing telemedicine in Arkansas as defined in the Arkansas Medical Practices Act and Rules. The PA will not perform telehealth in excess of the authority provided to the Supervising or Back up Supervising Physician.

By signing this document, the PA and supervising physician stated above do hereby acknowledge their complete understanding of the Arkansas State Medical Practice Act regarding delegative practice of the Arkansas State Medical Board and are fully aware of all responsibilities stated therein. It is further understood that a corresponding responsibility rests with the supervising physician to ensure safe and responsible practice by the PA.
